#### Overview

This mission is the first activity of IUC's component 2, i.e. to strengthen EU-Asia cooperation on local and regional climate change action, building upon the Covenant of Mayors initiative. The activity is developed for climate change experts of the Chinese Government, led by NDRC's Climate Change Department, which is in charge of China's Low Carbon Pilot Programme.

The working visit aims at providing Chinese representatives with practical and technical training regarding the EU's approach towards low carbon urban development, focusing on the EU Covenant of Mayors (now Global Covenant). The visit includes policy results (e.g. institutional setting and processes of the Covenant), methodological aspects developed by the JRC and practical implementation in cities of Belgium (Ghent), Portugal (Lisbon and Almada) and Austria (Vienna). EU cities have been chosen based on their track record on climate change mitigation and adaptation measures as well as on their experience on access to clean energy within the EU Covenant of Mayors.

The delegation is composed of 6 members, 3 NDRC representatives and 3 experts of the 2 entities appointed by the NDRC as possible institutions for setting-up a technical support secretariat for the the Covenant in China (see below). All members of the Chinse delegation have the required technical knowledge to be able to absorb the information they will receive and engage in exchanges with the European counterparts. Delegates will be supported by two IUC team members (Pablo Gándara, Shi Xin) and one interpreter (LU Ling). The group will be of 9 persons in total.

#### **Expected results**

The mission will pave the way for the possible implementation of a technical support secretariat for the Covenant in China. We expect to achieve following results:

- 3.1. The European Commission and NDRC will agree on a **roadmap** (governance structure) for setting-up a technical support secretariat for the Covenant in China.
- 3.2. Chinese participants will know in depth **technical know-how** the **EU Covenant of Mayors** works (goals, governance, role of cities the EU, national, regional and local governments, financing instruments, etc.)
- 3.3. Identification of **additional support** and concrete steps by the IUC project to aligning the Chinese Low Carbon Cities Programme with the Global Covenant of Mayors.
- 3.4. European participants will know in depth **competences of NDRC** Climate Change Department and the involved institutions (NCSC, IUDE, iGDP) with regard to the implementation of the Paris Agreement on Climate Change in China.
- 3.5. Chinese participants will learn **hands-on experiences** and best practices in European cities of different size and climate / geographic conditions.

#### Day 3 - Friday 22.09.2017 - Working visit to Ghent

Ghent – Belgium's 2<sup>nd</sup> largest city - has a municipal population of about 251.000 inhabitants (metropolitan areas of 591.000 inhabitants, 4<sup>th</sup> largest of Belgium). It is an economic hub of Belgium and Europe. The City of Ghent developed a Climate Adaptation Plan 2016-2019 containing a climate adaptation strategy and action plan, with local measures for the adaptation of the urban environment to climate change. In doing so, the City of Ghent is working on the development of a climate-robust city, and contributing to the European objectives for the creation of a climate-resistant Europe. The Ghent council approved the Climate Plan (SECAP) in January 2015, committing an investment of 105 million Euros in measures that directly contribute to reduced CO2 emissions for this legislature period (2013-2018). An additional budget of 40 million Euros is earmarked for measures indirectly contributing to reduced emissions. The final objective is to be climate neutral in 2050, or in other words: to no longer have a negative impact on climate. Ghent was also one of the finalists for the EU Green Capital 2019 award.

The visit will include meetings with local authorities and visits to projects implemented by the municipality, citizens' initiatives and the local business community.

# Day 7 - Tuesday 26.09.2017 - Working visit to Lisbon

Working day in Lisbon (Coordination Cristina Rocha, Head of Division of International Relations)

The capital of Portugal has a population of about 547.000 inhabitants and a metropolitan area with more than 2.8 million. Climate adaptation is now a very real concern for Lisbon. The city's biggest adaptation-related goals include the combination of energy and water issues, disaster risk reduction goals, improvement in public health, the creation of a biodiversity action plan, and the development of green infrastructure. Water scarcity is not a major problem as a result of significant investments made by water providers. However, resilience concerns indicate the importance of an improved urban water cycle management. Extreme temperatures in Lisbon are of increasing concern in terms of public health and energy demand. Thus, the urban heat island effect should be controlled. To tackle this, important investments are being made in the area of green infrastructure.

Lisbon is member of the EU Covenant of Mayors since 2007 and dispatched its Sustainable Energy Climate Action Plan (SEAP) in March 2008. Several best practices are available.

Vienna is a member of the Covenant of Mayors since 2012. Since 1999, Vienna has had a broad climate protection programme known as KliP I Vienna. Klip's I goal of preventing an increase in annual emissions of CO2 equivalents by 2.6 million tons by 2010 was already achieved in 2006. In fact, the city has thus far successfully avoided the annual emission of 3.1 million tons of CO2 equivalent. KLiP II (2010-2020) consists of 37 sets of measures with a total of 385 individual measures in the five fields of action:

- Energy supply
- Use of energy
- Mobility and town-structure
- Procurement, waste management, agriculture and forestry, nature conservation
- Public relations
