# City of Food is Bologna

## The **BOLOGNA CHARTER AGAINST FOOD WASTE**

a common commitment against food waste, was presented in Bologna in 2014 and signed at the Milan Expo in 2015, putting the fight against food waste at the heart of the priorities of the Italian Government and European Governments.









Il Mercato Ritrovato, the Farmers Market in Bologna was born in 2008 from a project by Slow Food, Cineteca di Bologna, Città Metropolitana di Bologna and Emil Banca.

The farmer's market is a fixed weekly appointment for the city, with only local and seasonal products, presented by those who produce. Over 50 local producers who sell directly, at fair prices, seasonal products at zero kilometers and the best quality of the territory.







Since 1998 Last Minute Market has been carrying out waste recovery services for large-scale retail trade. Thanks to networking with 350 stores and over 400 third sector entities, LMM currently recovers 55 thousand cooked meals, food products worth € 5.5 million, drugs for € 1,000,000 and more than 1000 tons of non-food products.











Metropolitan City of Bologna leads numerous initiatives to link the fight against **food waste** with promotion of **circular economy** principles: **reduce**, **reuse** and **recycle**.





Decrease volume lost to waste, by supporting the quality in agricultural production more than quantity as in organic farming.



#### **Agrifood Chain Sectors – Indicative Practices**

- •**Production**. Reduction of the environmental footprint of resources; sustainable use of water; exploitation of residues; alternative markets; etc.
- Processing. Industrial symbiosis; exploitation of wastes;
   sustainable packaging; etc.
- •Products/ Food supply. Avoid megapacks, change of promotion policies, food saving, composting, etc.
- •Consuming. Consumers behavior; efficient use of food; composting; etc.
